INSTRUCTIONS AND CONDITIONS OF BIDDING

1. **Receiving & Opening Location:** Bids will be received in the Administration Office at City Hall until the bid closing date and time indicated above. Bids will be opened in the Administration Office at City Hall immediately following the bid deadline. City Hall is located at 2 W Jackson St., Iola Kansas 66749.
2. **Submittal of Bids:** Bids must be submitted by mail, common carrier, or delivered in-person. Bids Must be received by 10:00 AM on March 3rd, 2026, and will not be accepted after the due date and time.
3. **Taxes:** Do NOT include Federal Excise Tax or Sales and Use Tax in the bid prices, as the City is exempt from them by law. Tax Exemption Certificate will be furnished if required.
4. The City of Iola reserves the right to accept or reject all or part of the bid, and to accept an offer deemed most beneficial to the City.
5. The successful bidder shall deliver each item F.O.B Destination to the City of Iola, N Industrial Rd, Iola Kansas. Prices shall include all applicable freight and handling charges. A Pre-Delivery service must be completed prior to delivery.
6. **Withdrawal of Bids:** Bids may be withdrawn without prejudice any time before the deadline for receipt of bids.
7. If a mistake or error is discovered by the bidder or the City of Iola after the bid opening, the City of Iola has the right to call this error to the bidder's attention and request verification of the bid.
8. Actual changes in the bid pricing, terms, and conditions shall not be permitted after the deadline for receipt of bids.
9. Identify the item you will furnish by brand or manufacturer's name and model numbers. Also furnish specifications and descriptive literature.
10. **Expenses:** All expenses for making Quotations to the City of Iola are to be borne by the bidder.

11. Bid Forms, Variances, and Alternates: Quotations must be submitted on the attached City of Iola Bid Form although additional information may be attached. Bidders must indicate any variances or alternates from the City of Iola requested specifications. Alternate bids may or may not be considered at the sole discretion of the City of Iola. The City of Iola reserves the right to consider the requested options as a whole, in part, or not as all when determining the best product that best serves the City of Iola's interest.

Dump Truck Bidding Specifications

1.0 INTENT

It is the intent of this specification to provide for the purchase of one (1) new and unused, current year model two-ton truck/dump truck to be used by the City of Iola Streets & Alleys Department.

The City of Iola has evaluated different styles of two-ton truck/dump truck and has determined that this published specification is best suited for our needs in terms of quality and features. This specification shall not be interpreted as restrictive but rather as a measure of quality and performance against which all other two-ton truck/dump truck will be compared.

In comparing proposals, comparison will not be confined to price only. The successful proposer will be one whose product is judged as best serving the interests of the City of Iola when price, product, quality, serviceability and delivery are considered. The City of Iola also reserves the right to reject any or all proposals or any part thereof, and to waive any minor technicalities. A contract will be awarded to the Vendor submitting the lowest responsible proposal that best meets the specifications and the interests of the City of Iola.

2.0 EQUIVALENT PRODUCT

Proposals will be accepted for consideration on any make or model that is equal or superior to the two-ton truck/dump truck specified. Decisions of equivalency will be at the sole interpretation of the City of Iola. A blanket statement that equipment proposed will meet all requirements will not be sufficient to establish equivalence. An original manufacturer's brochure of the proposed product is to be submitted with proposal.

On models or equipment not previously purchased by the City of Iola, a demonstration of the model may be required to ensure that it is capable of performing the needed functions.

3.0 INTERPRETATIONS

In order to be fair to all proposers, no oral interpretations will be given to any proposer, as to the meaning of the specification documents or any part thereof. Every request for such a consideration shall be made in writing. Based on such inquiry, the City of Iola may choose to issue an Addendum in accordance with local state laws.

4.0 GENERAL

The specification herein states the minimum requirements. All proposals must be regular in every respect. Unauthorized conditions, limitations, or provisions shall be cause for rejection. The City of Iola will consider as irregular or non-responsive any and all proposals that are not prepared and submitted in accordance with the proposal document and specification, or any proposal lacking sufficient technical literature to enable the City of Iola to make a reasonable determination of compliance to the specification. It shall be the proposer's responsibility to carefully examine each item of the specification. Failure to offer a completed proposal or failure to respond to each section of the technical specification will cause the proposal to be rejected without review as non-responsive. All variances, exceptions, and/or deviations shall be fully described in the appropriate section. Deceit in responding to the specification will be cause for rejection.
